





Number of open cases of anti-doping rule violations by Belarusian Athletes in **2022**




The work of the NADA Disciplinary Anti-Doping Commission, as well as the decisions on ineligibility made by NADA on 2022

As a result of the investigation of cases in 2022, NADA issued 19 decisions regarding athletes' ineligibility (13 decisions on cases of 2021), 7 cases were considered at meetings of the Disciplinary Anti-Doping Commission, where it was decided to apply a period ineligibility to 7 athletes (3 decisions on cases of 2021).

In all cases, the decisions were made legally and justified. There were no facts of cancellation and change of decisions.

Atypical Finding of Belarusian Athletes


There were 74 cases of abnormal biological markers detected in the analysis of athletes' samples. Further research was therefore carried out to clarify the nature of the abnormal biological markers.

According to the results of additional research, it was found 4 Atypical Findings reviewed by NADA.

For 3 samples the verification has been completed and no ADRV of the Republic of Belarus have been found.

Statistics on requests for TUE by Belarusian Athletes and the work of the BNADA TUE Commission for **2022**







Educational activities 2020/2021/2022




Number of participants of educational events



Educating persons responsible for anti-doping support

In order to improve the anti-doping awareness of the ORS specialists responsible for anti-doping support and in accordance with the request of the The Ministry of Sports and Tourism, the requirements of the World Anti-Doping Code and the International Standard for Education, an educational programme has been prepared and implemented in 2022.


Of the **49** declared specialists, **37** specialists completed Education, **35** specialists received a certificate based on the results of successful examination.






Online training and testing

An online course for persons responsible for anti-doping support was posted on the NADA's website in the "Training and Testing" section in 2022.






CERTIFICATES



The most frequently visited sections on the site are: Doping Control, Checking Medications or Dietary Supplements, Beware of Doping, Request for TUE, Prohibited List.




