














Number of open cases of ADRV (sport) **2023**

Highest number of warnings:

ice hockey (8 cases), track and field (5 cases) rowing (3 cases) The work of the NADA Disciplinary Anti-Doping Commission, as well as the decisions on ineligibility made by NADA on 2023

As a result of the investigation of cases in 2023, NADA issued 16 decisions regarding athletes' ineligibility (8 decisions on cases of 2022), 4 decisions to discontinue the investigation and results management (2 decisions on cases 2022).

3 cases were considered at meetings of the Disciplinary Anti-Doping Commission, where it was decided to apply a period ineligibility to 3 athletes.

In all cases, the decisions were made legally and justified. There were no facts of cancellation and change of decisions.

Anti-Doping Rule Violations at «II Games of the CIS countries»

1 ADRV committed by a Belarusian athlete (athletics) and 4 ADRV committed by athletes from the Russian Federation muaytai (2 violations), weightlifting (1 violation), judo (1 violation)



Atypical Finding of Belarusian Athletes


There were 68 cases of abnormal biological markers detected in the analysis of athletes' samples. Further research was therefore carried out to clarify the nature of the abnormal biological markers.

According to the results of additional research, it was found 3 Atypical Findings reviewed by NADA.

For 2 samples the verification has been completed and no ADRV of the Republic of Belarus have been found.

1 samples are being checked.


Statistics on requests for TUE by Belarusian Athletes and the work of the BNADA TUE Commission for **2023**





Educating persons responsible for anti-doping support

In 2023, a programme was prepared and implemented to educate and train specialists responsible for anti-doping support in sports federations (unions, associations) and republican Olympic training centres.

The program consisted of **10 seminars**, **4 intermediate tests** to monitor knowledge and a final exam, which included the verification of theoretical knowledge and practical skills.


The training was attended by **73 specialists**; **47 specialists** passed the exam and received the certificate.





An online course for persons responsible for anti-doping support is posted on the NADA's website in the "Training and Testing" section.






In 2023, the site was visited 88,500 times. 75% of visitors used a smartphone


