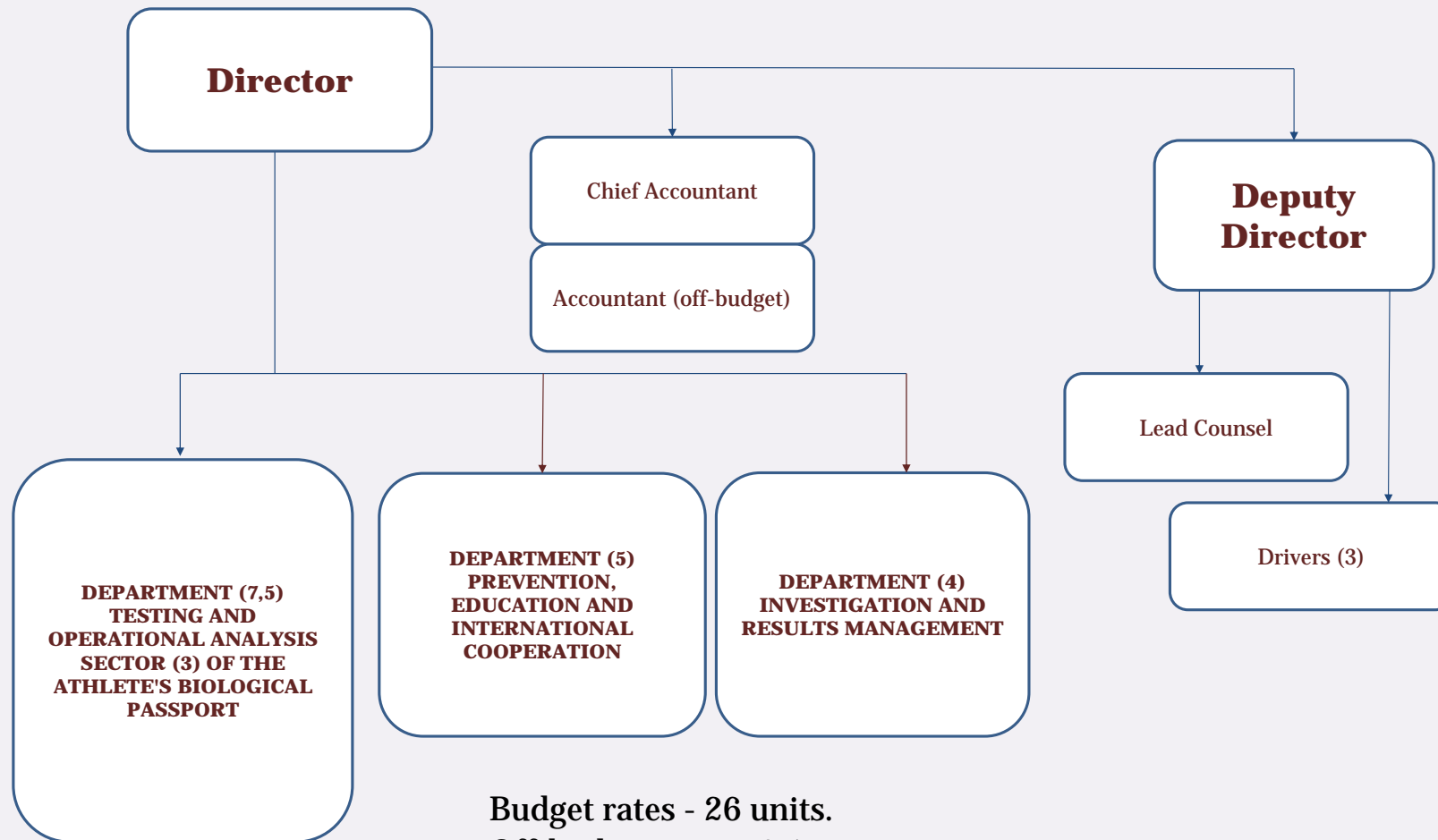


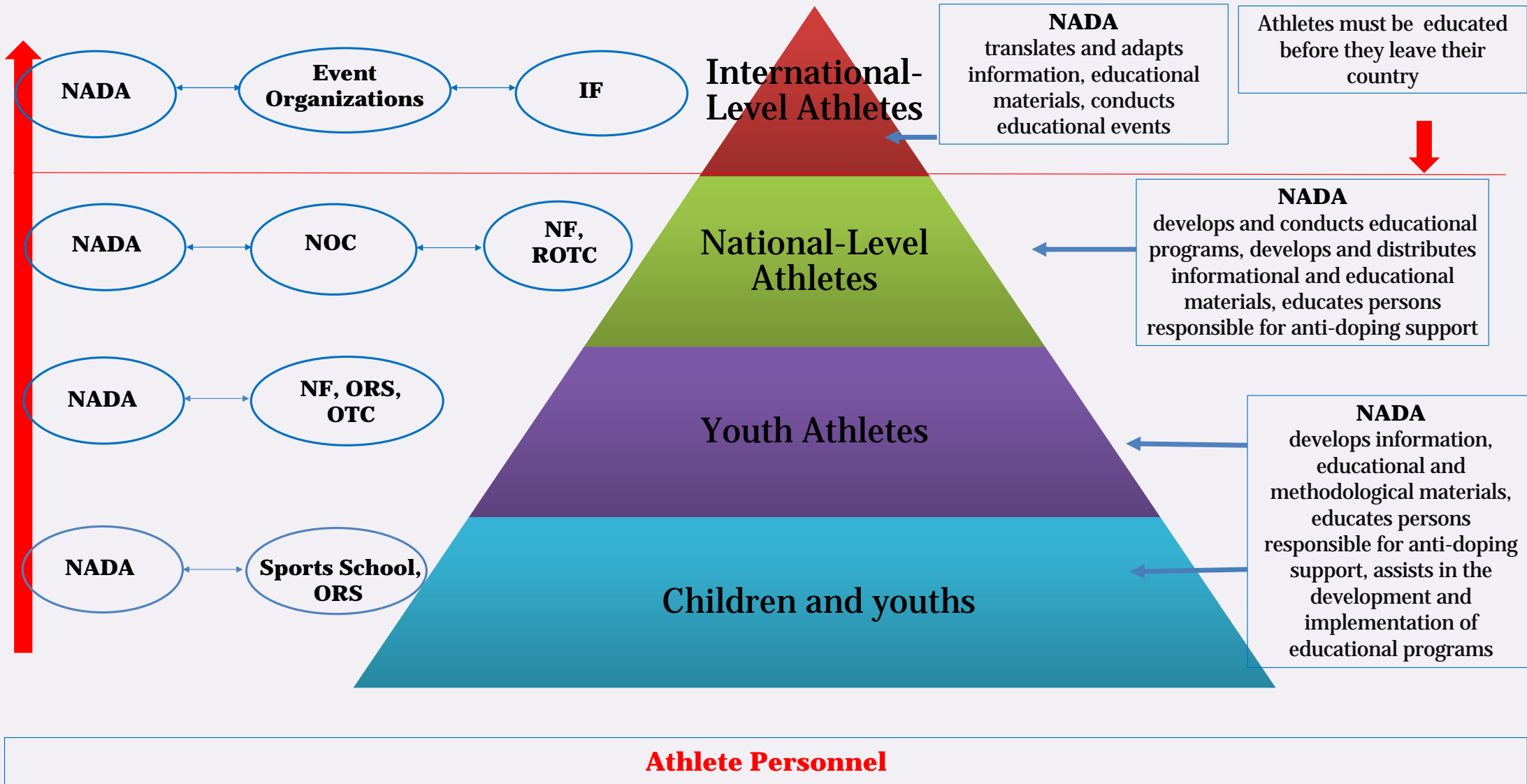

NADA's structure

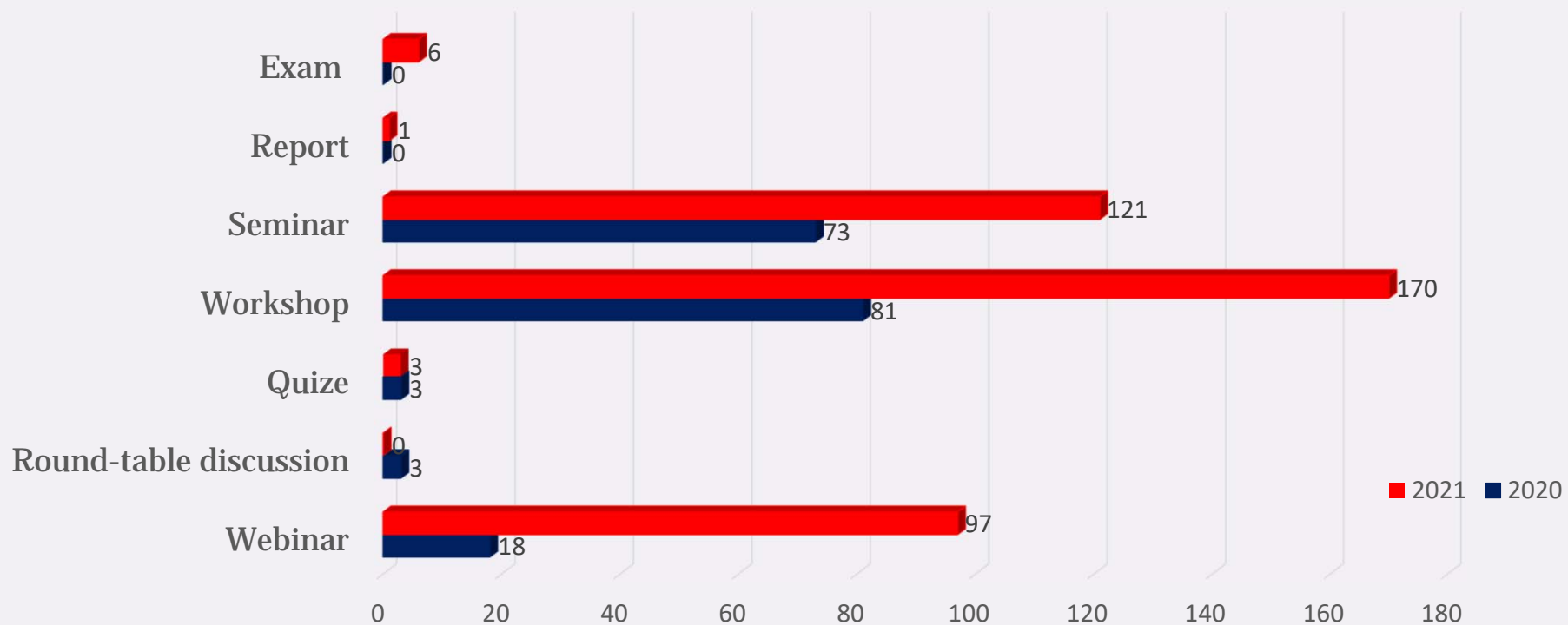


Budget rates - 26 units.
Off-budget rates - 1.5 units.

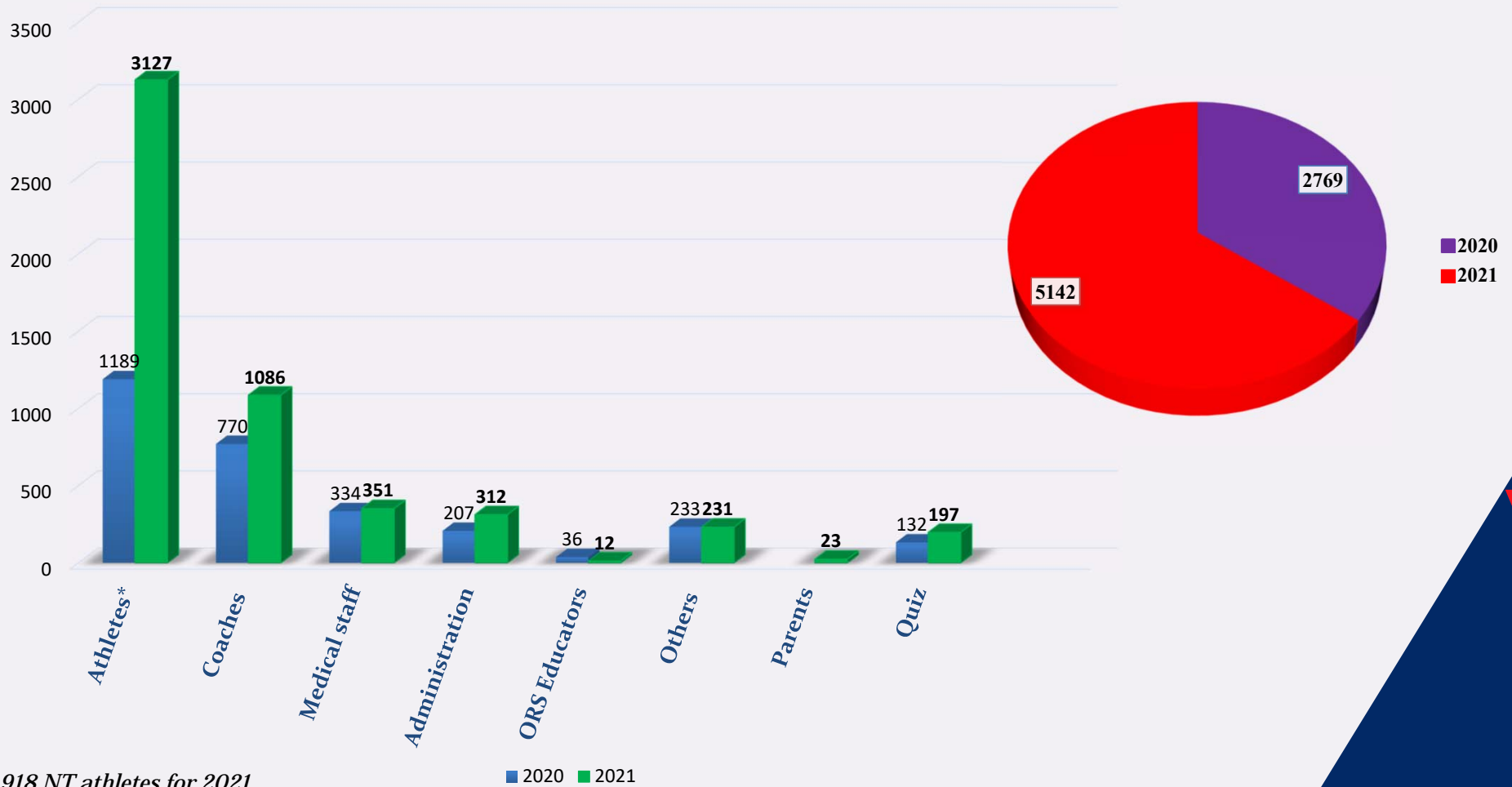

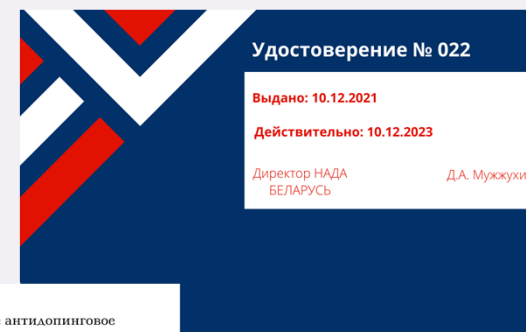

Educating persons responsible for anti-doping support

In 2021, a programme was prepared and implemented to educate and train specialists responsible for anti-doping support in sports federations (unions, associations) and republican Olympic training centres.

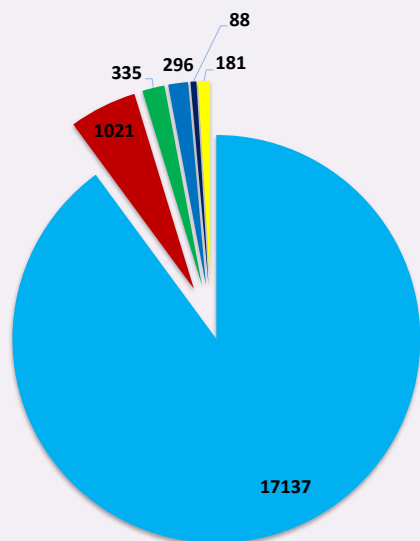
The program consisted of 8 seminars, 3 intermediate tests to monitor knowledge and a final exam, which included the verification of theoretical knowledge and practical skills.

The training was attended by 49 specialists; 22 specialists passed the exam and received the certificate.

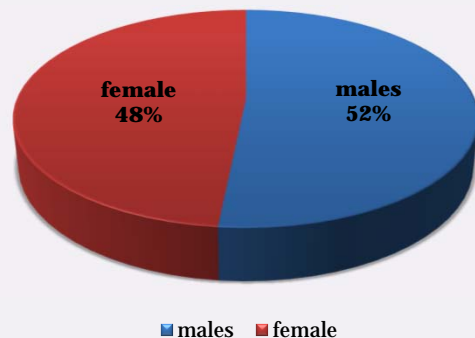

Age groups

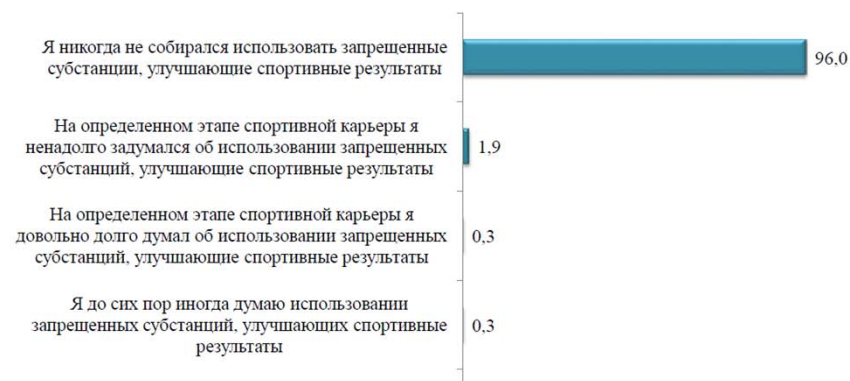

The research was attended by **624** athletes included in the National Teams of the Republic of Belarus.



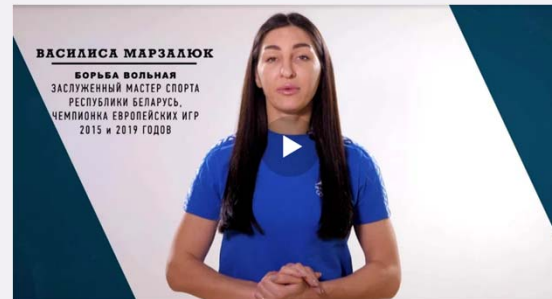
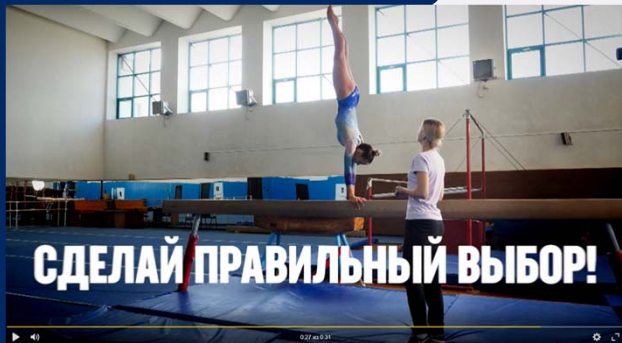
Какое из утверждений лучше всего описывает Вашу ситуацию? (в %)



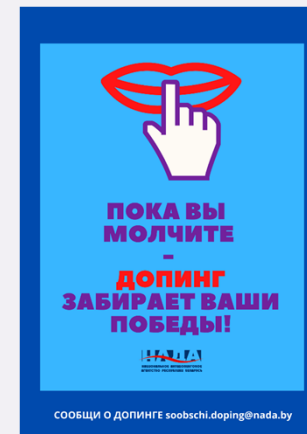
Как часто Вы употребляли следующие виды субстанций в течение последних 12 месяцев? (в %)

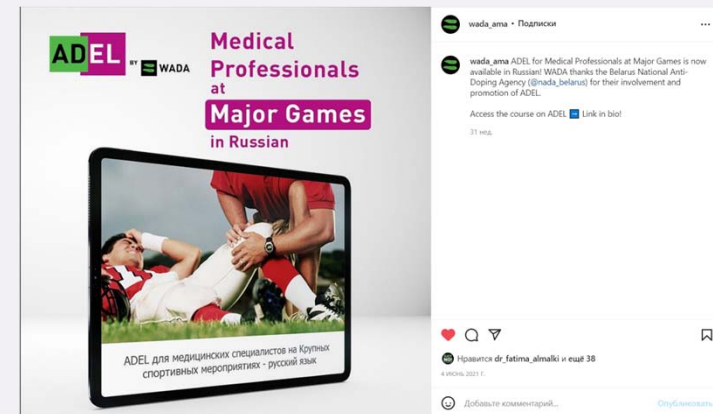

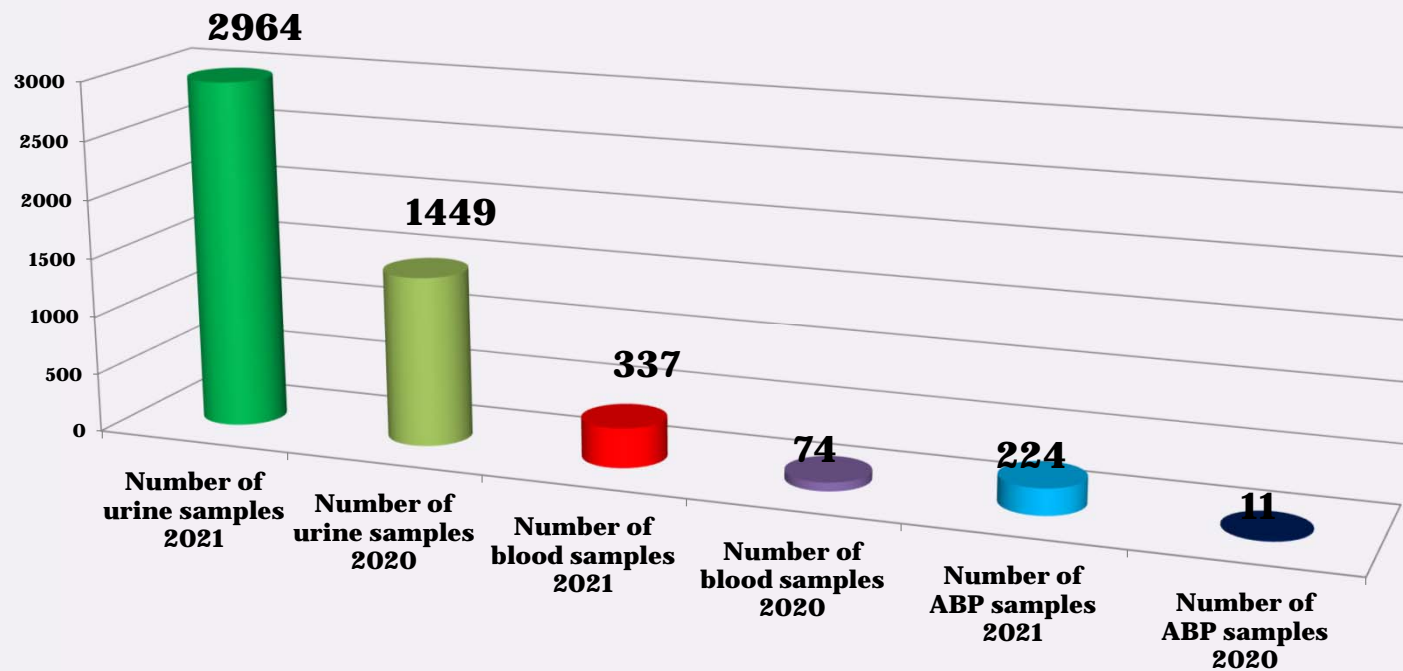

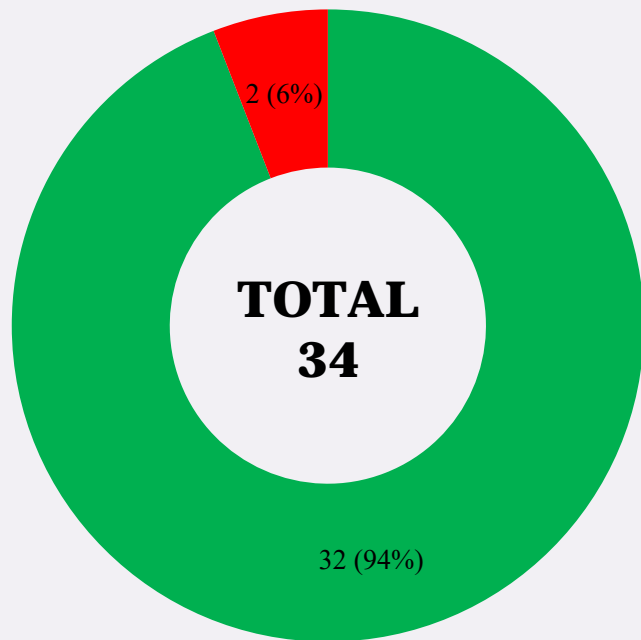

■ Cases, opened by International anti-doping organisations

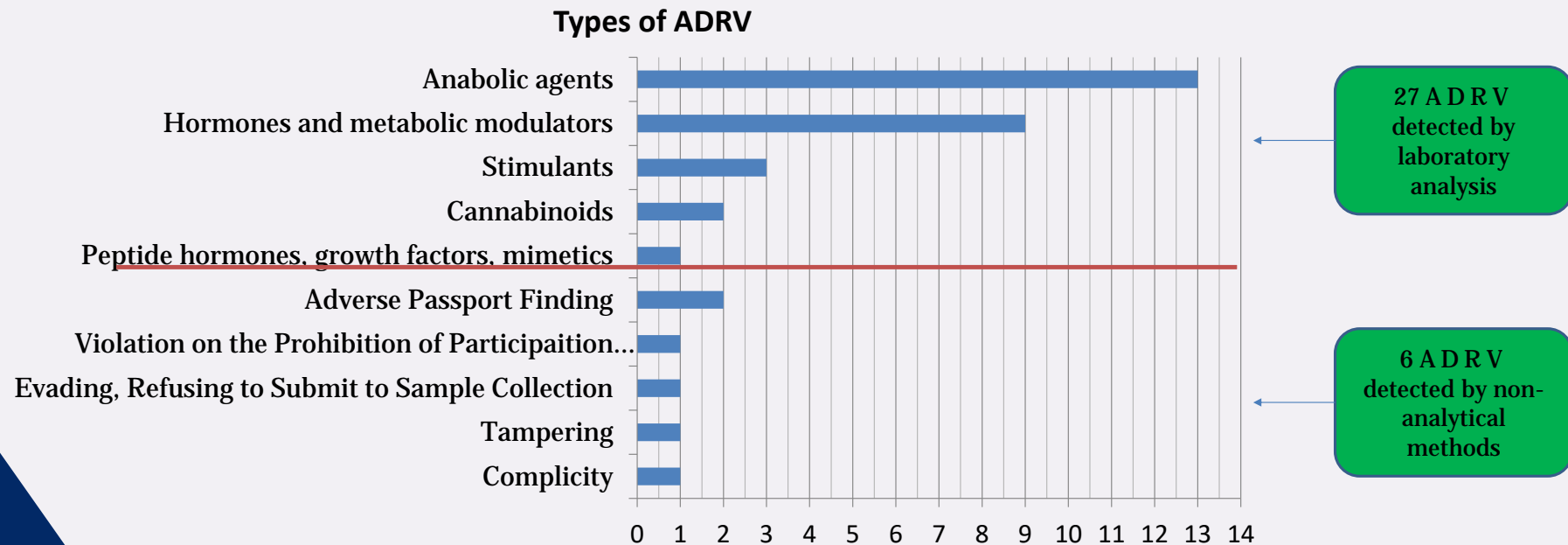

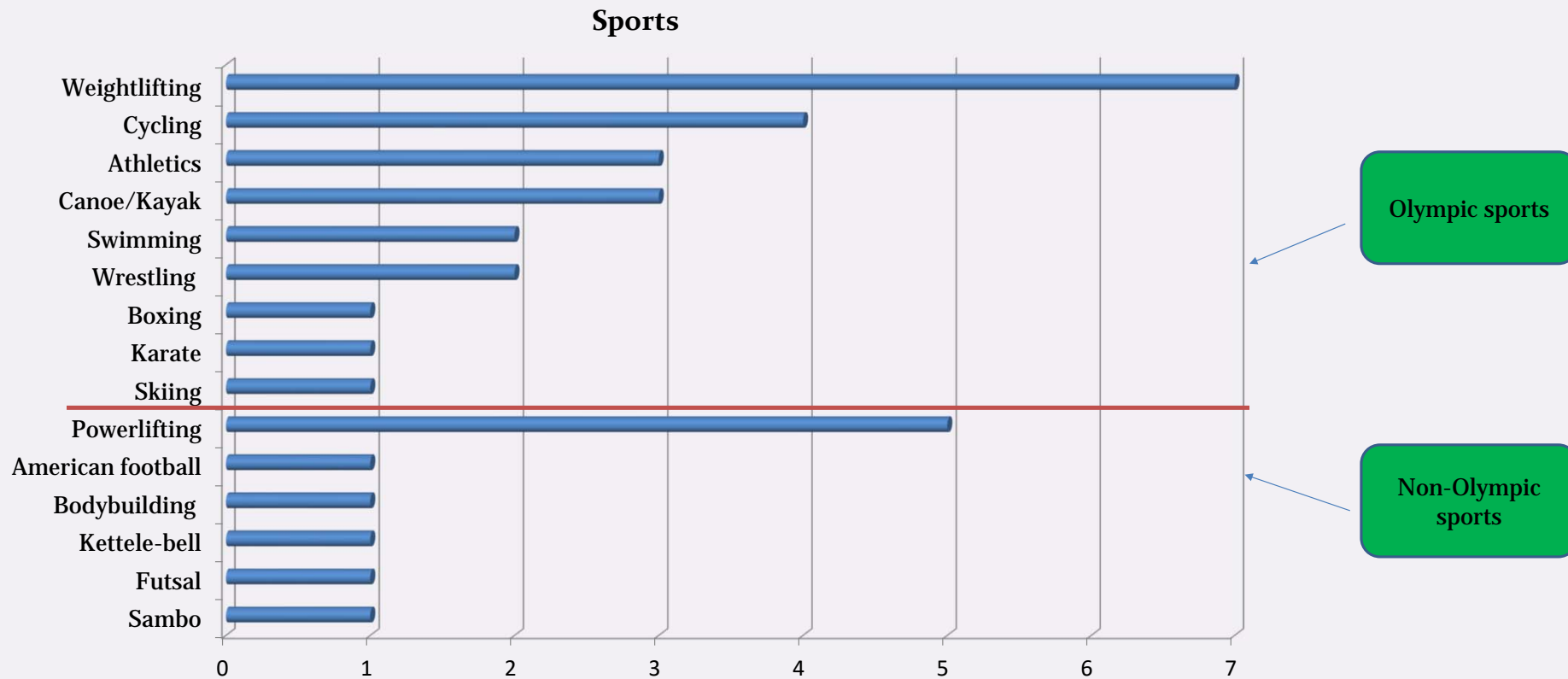

Number of open cases of ADRV (sport) 2021

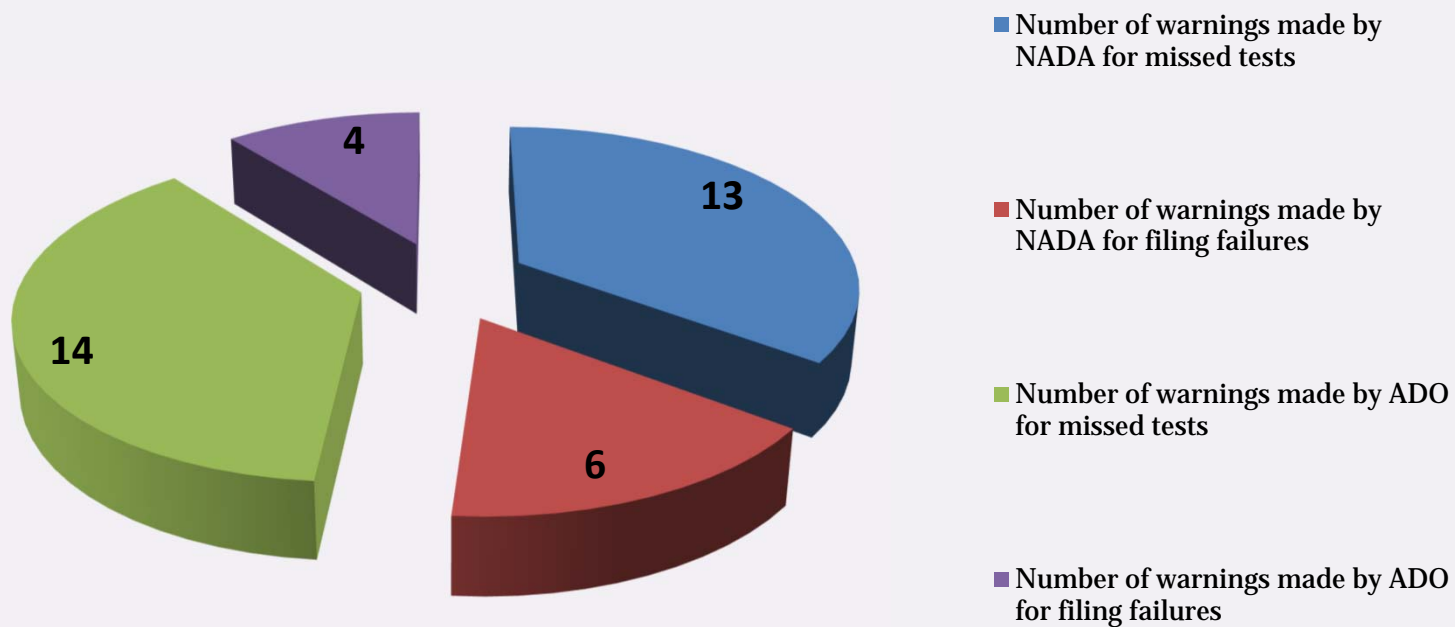


Atypical Finding of Belarusian Athletes

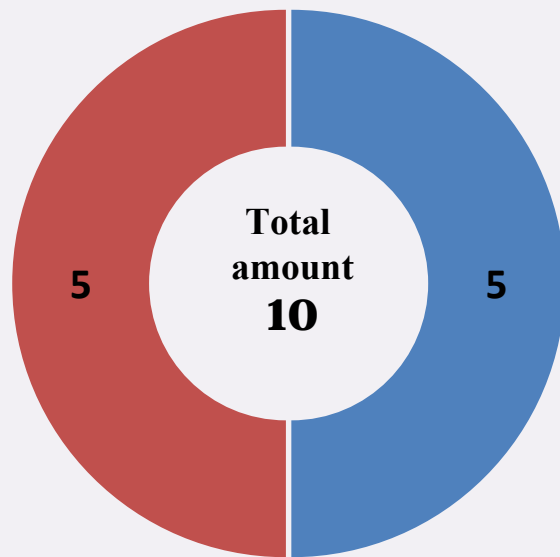
There were 87 cases of abnormal biological markers detected in the analysis of athletes' samples. Further research was therefore carried out to clarify the nature of the abnormal biological markers.
